## RULES AND REGULATIONS of the BOY SCOUTS OF AMERICA Pertaining to the Silver Antelope Award Amended October 12, 2021

The Boy Scouts of America, acting through the National Court of Honor, may award the Silver Antelope for distinguished service to youth upon the following basis and procedure:

- (a) This award may be made each year. The nomination must be submitted no later than November 30 using the Silver Antelope nomination form. This award may be made for noteworthy service of exceptional character to youth by registered Boy Scouts of America volunteers.
- (b) As evidence of the award there will be presented: a suitable certificate, duly authenticated by the Boy Scouts of America, pursuant to the action of the National Court of Honor; and a miniature silver antelope suspended by an orange, white, and orange ribbon to be worn around the neck.
- (c) The National Court of Honor will select the recipients based upon nominations received and the number of recipients will not exceed thirty-two annually. No public announcements are to be made in advance of action of the National Court of Honor with reference to the names presented for consideration.
- (d) These awards are to be presented to the recipients at a noteworthy national service territory meeting or national event or meeting, but only after approval of the award by the National Court of Honor.
- (e) Each national service territory is entitled to two recipients per year. Recipients may be nominated and selected for their efforts on the national service territory committee and/or for service to the national service territory through various national committees.
- (f) Unused allotments for any previous years may not be accumulated or used in any subsequent year.
